I. Welcome and Announcements

After greeting everyone and introducing herself, MDC Director of Membership and Partnership Marybeth Weiseberg provided details for the new format, i.e., change our view to speaker view while in the panel discussion, use the chat function to insert questions for the panelists, once we're moved into the breakout sessions microphones will be enabled so we can introduce ourselves and chat with each other. Regarding current events, the trial of [former MPD police officer] Derek Chauvin (https://en.wikipedia.org/wiki/Derek Chauvin) continues. Jury selection is continuing today, arguments are scheduled to start on March 29th, the MDC continues to send out regular communications to keep the downtown community apprised, and there's a link on their website (https://www.mplsdowntown.com/trial/).

Also, there was very encouraging news last week when Governor Walz appropriately turned the dial on some of the pandemic related restrictions that were impacting economic activity. They can start to come back a bit and are super excited they'll have 10,000 Twins fans at Target Field on April 8th for Opening day. They're also anxious to see restaurants bounce back with more in-person capacity as well as a significant investment from the federal government in the American Rescue Plan Act of 2021 (https://www.ncsl.org/ncsl-in-dc/publications-and-resources/american-rescue-plan-act-of-2021.aspx); they'll be making sure all restaurants are aware of that opportunity.

ETBP Executive Director Dan Collison also thanked everybody for taking time today to be together; he's impressed at how everyone is showing up, doing hard work to understand themselves and their organizations to help Minnesota and downtown Minneapolis become a better place. He commented it's been an honor to serve on the staff of the MDC, and extended thanks to all ETBP Board and its members for caring, engaging, and being a part of leading all of this to a better place as the year moves forward.

Then he announced the ETBP annual meeting on Thursday, April 15th at 11:00 a.m., and described its program (https://easttownmpls.org/etbp-annual-meeting-on-april-15-at-11-a-m-via-zoom/). As the ETBP moves carefully, thoughtfully, and assertively into the year to bring visitors back, continue to grow housing, and focus on what matters to all Minnesotans in downtown, they really need our engagement and would love to have us participate.

Collison advised what is clear to the MDC event planning team and ETBP is as we move through this phase of emergence, they need to pay attention to their nonprofits, and Minnesota is famous, perhaps worldwide, for being very civically minded and having nonprofits for all the needs and concerns they have, and they want to make sure the business community is paying attention to leading nonprofits.
