- Introductions and Expectations (agreements in Agenda above)-
  - HCMC and Bethlehem Baptist Church not in attendance; invited but couldn't make it
  - CM Osman, Parks Commissioner, MPD, etc. are in contact with Coalition but will not be in regular attendance, will be emailed notes as needed
  - Residents feel Catholic Charities has been "historically absent" from conversations and are happy to meet employees going forward

- Small Group Activity: Partner in groups of three to discuss the best experiences you've had in any park
  - Activations and full-time staffing make more exciting
  - Amenities = playground, pool, trees for shade and privacy
  - Connection to nature
- Prior to Soccer Field and Skate Park, Elliot Park had a Baseball Diamond and Tennis Courts renovations from MPRB coming in the next year will address the Basketball Courts
- However, focus of coalition is not on infrastructure improvements
- Small Group Activity: Partner with one person and pick a POV from any park user (from last meeting's list) and Elliot Park map- What is the experience of that person? What do they do and where do they go? What is most or least enjoyable?

- Two sides of Elliot Park (East and West, due to Rec Center blocking visibility and thru-traffic), currently seems to be a disadvantage but could be great and is intended for sectioning off activities
- Is this divide exacerbated by the closure of Segue Coffee (which in turn is due to safety concerns) because less people are crossing through the park?
- Activation, programming, and events are keys to great communities and public spaces
  - Ideas include chess, bocce, ice hockey, winter carnivals, book clubs, sports matches, concerts, picnics (need grills/benches/infrastructure), etc.
- Resources need to spread past the park's boundaries into community- Elliot Park is a neighborhood experiencing food scarcity (limited grocery and restaurants)- *due to or preceded by safety concerns*?
- Break-ins span outwards to nearby apartments, fencing and lighting hasn't always been a helpful solution, but could be in combination with other tactics
- Decreased bus stop shelters, increased encampment sweeps, and several other factors invite people to hold space in Park- many people also deny services; however, housing instability is not exclusively something the Coalition will touch
- Amenities for senior citizens, people with disabilities, and more would be inviting, trash pickup would be helpful in keeping park safe and clean for users (*EPNI does clean-ups semi-regularly*)
  - Keeping pool (not splash pad) safe, clean, and accessible is important in the summer, skatepark is public (open for event hosting) = good bones of the park
- Acute care services nearby and Twin Cities' needle exchanges cater to unhoused residents and people struggling with addiction, preference for privacy when struggling and park provides anonymity
  - Are there volunteering opportunities? What do they look like?
- Residents experience lack of dedicated parking for park-users and public restrooms (exterior restrooms are closed with the exception of during open pool hours)

## Next Steps:

- Meeting in January- starting biweekly (or so) and eventually becoming monthly as we establish goals, mission, etc.
- Next meeting will be a discussion of Coalition's mission and vision

Generally, Coalition will:

- Utilize winter/off-season to gather steps and eventually present actions/commitments and seek funding
- Require attendance, partnership, and (eventually) advocacy
  - The benefit of everyone at the table is there are people who can take actions at their organizations and at the park
